Be It Resolved That Council receives for information the Clerk/Planning Manager and Chief Building Official's Administrative Report entitled "Shipping Container – Draft By-law";

And That Council receives for information the draft By-law to Licence, Regulate and Govern Shipping Containers and instructs the Clerk to make the following amendments to the draft By-law:

- By-law to apply to Hamlet and Waterfront properties only;
- Not applicable to properties with building permits until 30-60 days after final inspection;
- Other contractors placement until end of project;
- Not applicable to Commercial use within the Hamlet and Waterfront Zones; and
- Provide the By-law to Council at the next Council Meeting for Council's consideration;

And That Council approves in principle the following proposed fees, subject to a Public Meeting to amend the Fees and Charges By-law to include:

- Licence a Shipping Container 15 square metres or less - Nil
- Licence a Shipping Container exceeding 15 square metres - \$150
- Administration Fee for Shipping Container placed without a Licence \$300;

And That Council instructs the Clerk to schedule a Public Meeting to consider amendments to the Fees and Charges By-law for Shipping Containers.
