**BY-LAW NUMBER 2010-49**

**BEING A BY-LAW TO AMEND BY-LAW NUMBER 2000-85, THE OFFICIAL PLAN FOR THE TOWNSHIP OF SOUTH FRONTENAC, AS AMENDED, TO CHANGE THE DESIGNATION ON SCHEDULE 'A' LAND USE PLAN AS IT RELATES TO PART LOTS 39 & 40, CONCESSION VII, DISTRICT OF STORRINGTON: McCALLUM.**

**WHEREAS**, the Municipal Council of the Township of South Frontenac deems it expedient to amend By-law Number 2000-85, the Official Plan for the Township of South Frontenac, as amended, as it relates to a parcel of land located in Part of Lots 39 & 40, Concession VII of the District of Storrington.

**NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF SOUTH FRONTENAC BY ITS COUNCIL, HEREBY ENACTS AS FOLLOWS:**

1. **THAT** Schedule "A", Land Use Plan, to By-law Number 2000-85 as amended, is hereby further amended by changing the designation from Rural to Mineral Aggregate, for those lands shown on the attached map designated as Schedule "1".
  
2. **THAT** the Clerk is hereby authorized and directed to make application to the Minister of Municipal Affairs and Housing for the approval of Amendment Number 12 to the Township of South Frontenac Official Plan.
  
4. **THAT** this By-law shall come into force and take effect on the day of passing of the Official Plan Amendment Number 12 by the Minister of Municipal Affairs and Housing.



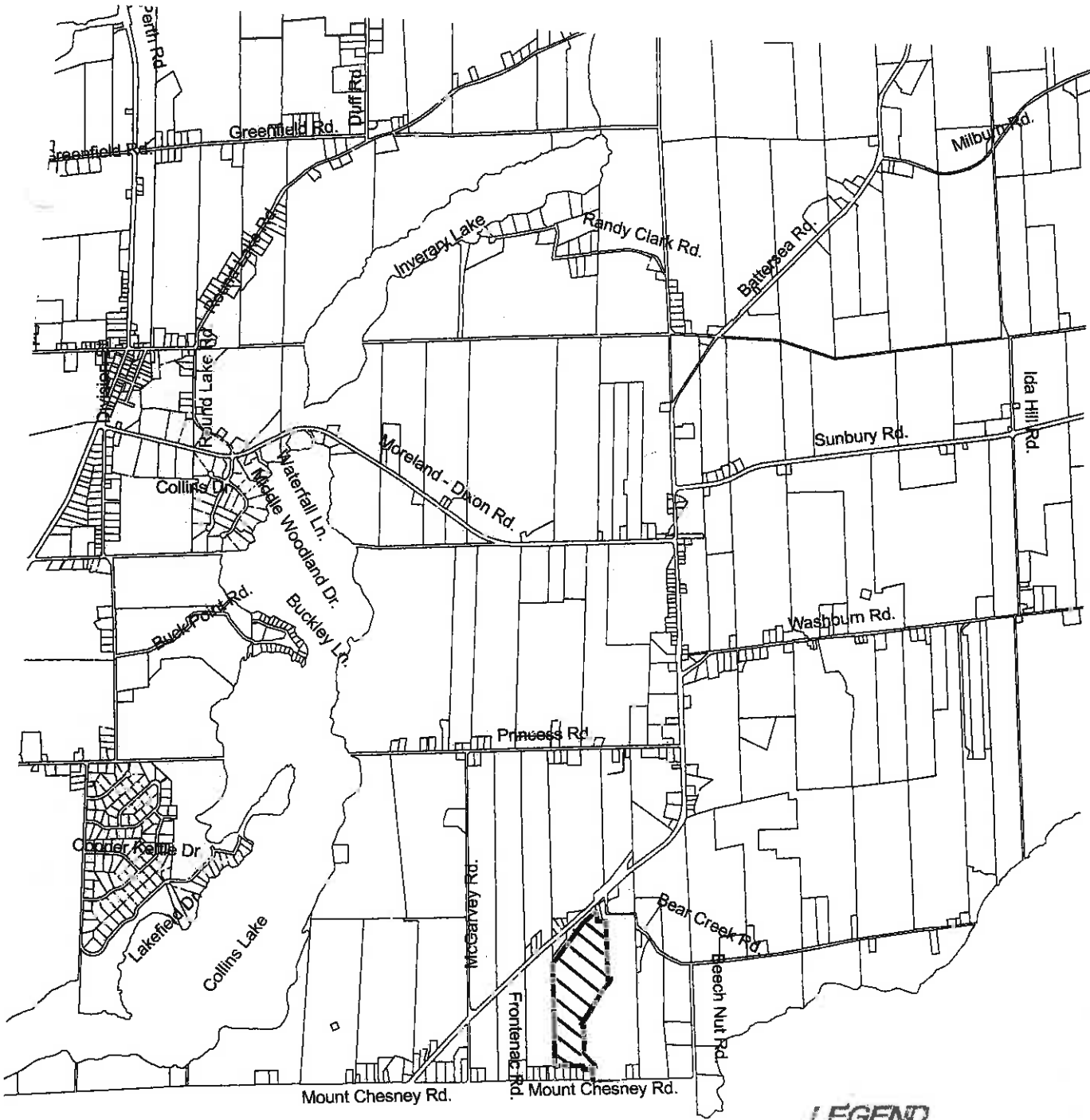
