**BEING A BY-LAW TO AMEND BY-LAW NUMBER 2003-75, AS AMENDED,  
TO REZONE LANDS FROM RURAL ZONE (RU) TO LIMITED SERVICE  
RESIDENTIAL-WATERFRONT ZONE (RLSW) AND SPECIAL LIMITED  
SERVICE RESIDENTIAL-WATERFRONT ZONE (RLSW-67); PART LOT 6,  
CONCESSION XIV, DISTRICT OF PORTLAND: PEPPER**

**WHEREAS, the Municipal Council of the Township of South Frontenac deems it expedient to amend By-law Number 2003-75 as amended, as it relates to a parcel of land located in Part of Lot 6, Concession XIV of the District of Portland,**

**NOW THEREFORE THE CORPORATION OF THE TOWNSHIP OF SOUTH FRONTENAC BY ITS COUNCIL, HEREBY ENACTS AS FOLLOWS:**

1. **THAT** Schedule 'A' to Zoning By-law Number 2003-75 as amended, is hereby further amended by changing the zoning from Rural Zone (RU) to Limited Service Residential-Waterfront Zone (RLSW) and Special Limited Service Residential-Waterfront Zone (RLSW-67) for those lands shown on the attached map designated as Schedule "1".
  
2. **THIS BY-LAW** shall come into force in accordance with section 34 of the Planning Act, 1990, either on the date of passage or as otherwise provided by section 34.

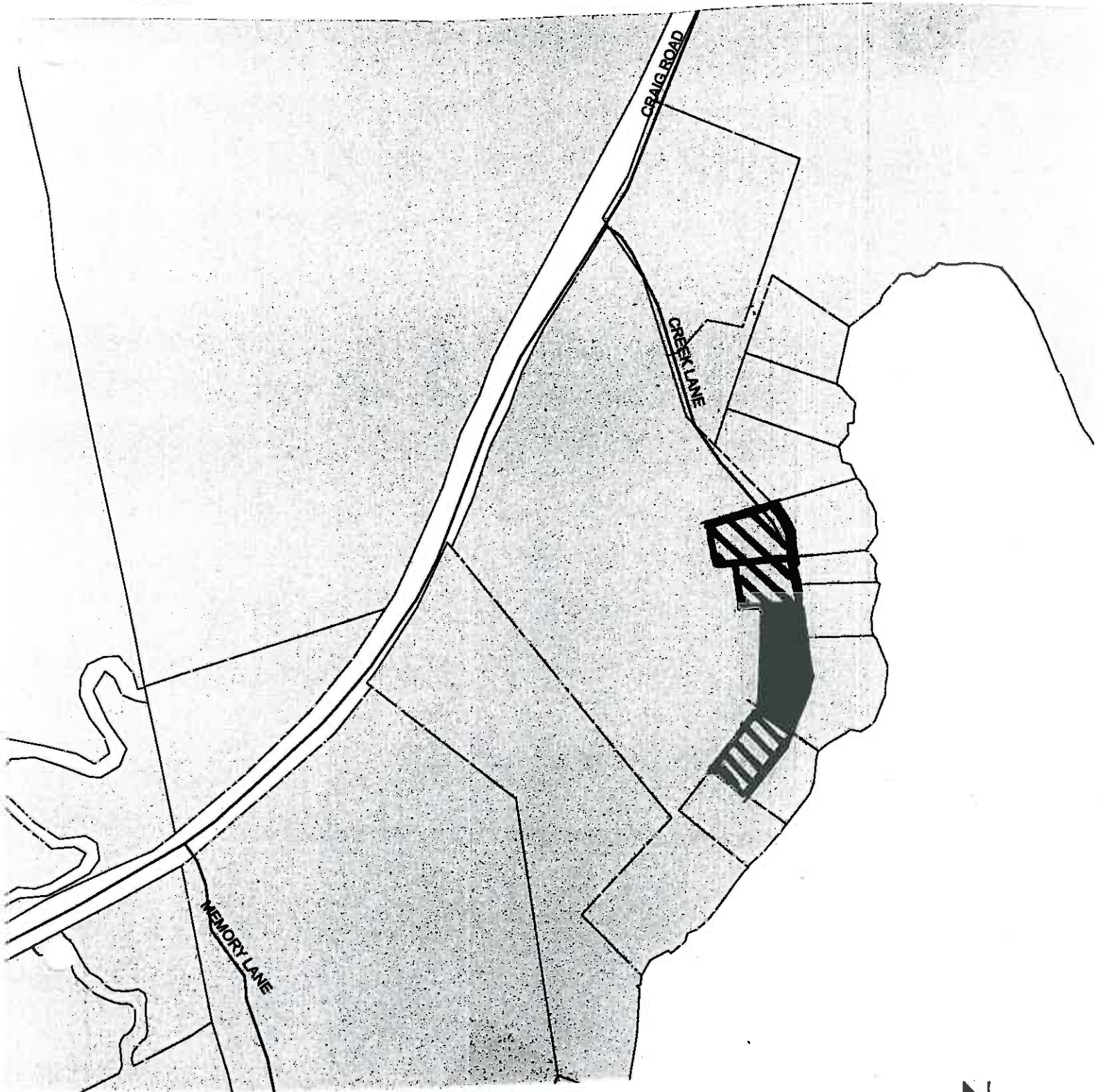
